2019 Membership Agreement

The Links at Lang Farm membership agreement ("Agreement") is for the 2019 golf season, or state date noted below by and between The Links at Lang Farm (The Links) and the Member listed below.

- ☞ Pursuant to the terms of this Agreement, The Links at Lang Farm will grant access to the golf course to the membership holder during normal business hours as set by The Links for the agreed member rate, and depending upon the member's level.
- ☞ Memberships are non-transferable. The Agreement is conditioned upon acceptance and completion of this form and receipt of all applicable fees. **Membership fees are non re-fundable.**
- ☞ Members are responsible for themselves and their guest when playing golf at The Links at Lang Farm. Members will be held responsible for any and all damages to The Links property as well as the surrounding private properties. Damage to the golf course or physical property owned by the golf course, if deemed caused by neglectful behavior, may result in suspension or loss of membership privileges.
- ☞ Membership holders are not guaranteed tee time. Management reserves the right to sell, advertise and market The Links in any manner. The Links reserves the right to schedule golf events / tournaments / leagues. During such events, membership holders may not be able to use the golf course. The Links will endeavor to schedule such events during off-peak times.
- ☞ The Links does not allow guaranteed access to the course without a tee time. Tee time cancellation is requested 48 hours in advance.
- ☞ Any membership holder who violates the rules and regulations contained in this document shall be subject to fine, suspension and or immediate revocation of his or her membership. All membership holders found to be in violation of the rules and regulations may be denied privileges to the facility. The denial or privileges may apply to one or more family members in management's sole and absolute discretion.
- ☞ A membership may be revoked or suspended for any of the following reasons, or any deemed by the management or staff to be unacceptable conduct which seriously detracts from management's absolute right to manage the club; physical or gross verbal abuse of staff members or customers; willful destruction of the club, or private property, commissions of any felony or misdemeanor theft at the club or a violation of any rule or policy set by management at any time. All rules are subject to change based on needs of the business without notice.
- ☞ Each member agrees to abide by all of the rules and regulations established by The Links. Such rules may include, without limitation, rules regarding proper conduct, dress code and golf etiquette. The Links reserves the right to periodically change all rules and regulations as it sees fit without notice.
- ☞ The Links reserves the right to refuse sale of a membership to any person or party and is not responsible for any personal items either lost or stolen on the property at any time. Membership includes 2 large baskets of range balls per day and do not carry over. Range use may be limited or closed without notice. Corporate Membership restrictions apply, see official Corporate Membership Offer for more information.
- ☞ Members and their guest assume all risks associated with playing the game of golf.
- ☞ Junior Members shall only play during "Junior-Hours" and are deemed as follows: Monday – Friday (Open – 3:40pm) & Saturday – Sunday (After 2:00pm), unless playing with an adult (18 years of age or older).
